This Copyright License Agreement signed in accordance with the Copyright Law of the People's Republic of China transfers the copyright of the manuscript to the International Journal of Ophthalmology Press, which includes the following aspects:

1 All the author(s) agree that once the manuscript is accepted by International Journal of Ophthalmology (IJO), the author(s) agree to transfer the copyright, including but not limited to the copy right, distribution right, information network dissemination right, performance right, translation right, compilation right, adaptation right and other rights of the contribution to IJO within the copyright protection period. IJO Press has the right:

- a) copy, distribute, and disseminate the work in various known or possible forms, formats, and media (including but not limited to paper, CD, disk, network, *etc.*) including but not limited to the following ways;
- b) translation, adaptation, compilation of the work, and the use of charts, abstracts or any part of the work to derive other works;
